Planned Parenthood is Hiding Something

Mr. SMITH of New Jersey -- In its slick TV ads and PR blitz, the billion-dollar-a-year abortion giant Planned Parenthood appears to be hiding something.

Could it be they are hiding the dismaying fact that just one organization—Planned Parenthood—today performs over 25% of all abortions in America? No other chain of abortion mills even comes close.

Or is it the fact that 97% of all so called services rendered to a woman with child end in an abortion?

Or, the fact that since 1977 Planned Parenthood has deliberately caused the brutal death of well over 5.4 million babies. And in 2009 alone, over 332,278 babies, were killed in Planned Parenthood clinics. (The death stats for 2010 and for the first four months of 2011 haven't been publicized yet.)

There is no organization in America, perhaps even on earth, that stabs, dismembers, decapitates, or chemically poisons more unborn children to death, than Planned Parenthood.

For the innocent and perhaps inconvenient child in the womb, a Planned Parenthood abortion clinic is a house of horrors – a place where abortionists brutally destroy unborn children and deceive and hurt their mothers.

Taxpayers shouldn't be coerced into subsidizing and giving hundreds of millions of dollars each year to Child Abuse Inc.

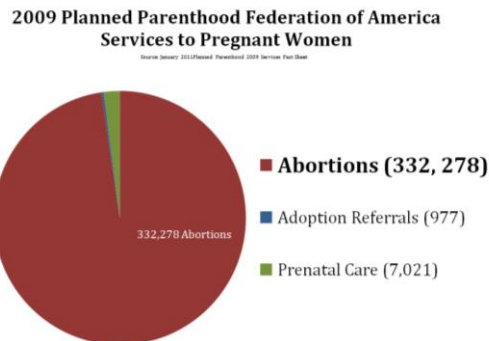
Black/Roby Enrollment Correction

FACT: If enacted the Black/Roby enrollment correction resolution would eliminate federal funding for the largest abortion provider in America, Planned Parenthood, for the 2011 fiscal year.

FACT: Planned Parenthood is to be the largest abortion provider in the nation committing **332,278 abortions in 2009 (the last reported year) and 5.4+ million abortions since 1977** (and more if you include prior years for which data is not available).



FACT: According to their own statistics for 2009 - the year in which they carried out 332,278 abortions – Planned Parenthood **only provided 977 adoption referrals and 7,021 prenatal services** (see chart). This disparity is consistent with prior years.



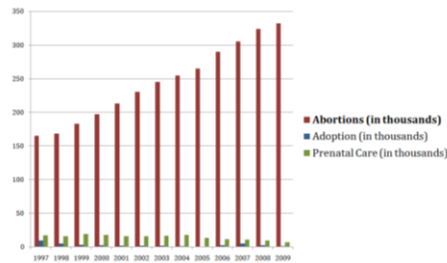
FACT: More than **one-third of the income at Planned Parenthood affiliated clinics, in the aggregate, is generated by selling abortions.**

FACT: Planned Parenthood's central office has **directed all affiliates to have at least one abortion clinic** in their regional Planned Parenthood chain by 2013.

FACT: As was the case with the Pence amendment, **the Black/Roby resolution does not reduce funding for women's health or family planning.** It simply ensures that the funds are directed to other organizations. Not a dime of women's health or family planning funding is reduced by the Black/Roby resolution.

FACT: Over the years Planned Parenthood has **increased their abortion numbers every year** while adoption and prenatal care numbers remain shamefully low.

FACT: A [poll](#) conducted by *the polling company, inc./WomanTrend* released April 12, 2011 demonstrated that 54% of those polled oppose “tax dollars for family planning services going to organizations that perform abortions.”



FACT: Planned Parenthood is NOT the only entity that can deliver family planning services in America. Individuals can also obtain family planning services at other clinics including community health centers and state health departments. Federal funding for these services is plentiful.

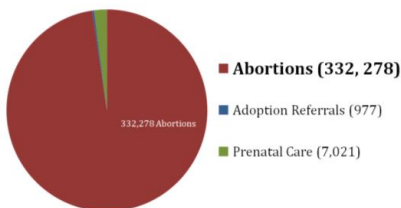
FACT: As was the case with the Pence amendment, the **Black/Roby resolution does not reduce the nearly \$1.4 BILLION in Medicaid dollars to be spent this year for family planning** for low income women. The resolution also does not reduce Title X.

FACT: Planned Parenthood advocates claim they do mammograms, yet there is no evidence that they consistently provide mammography services at their clinics. They talk about addressing diabetes, high blood pressure and other general health care for women. Yet, their 2009 summary of services indicates that **they provided primary care to fewer than 20 thousand clients – a small number compared to the over 330 thousand unborn lives exterminated in their clinics.**

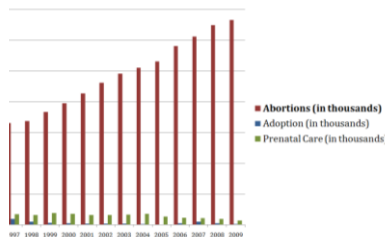
