## Representative Smith:

Please allow this correspondence to notify you of the Township of Berkeley's great need for transportation improvements. As Mayor of Berkeley Township, I am privy to the concerns and issues that our town faces, and none is more important than the need to improve the Bayville section of Berkeley Township's Road network. Our township applied for funding, unsuccessfully under the Bipartisan Infrastructure Investment and Jobs Act, as the State of New Jersey will be receiving \$15 billion for various infrastructure improvements. The extension of Western Blvd is an excellent project to be funded by the FY24 appropriations, as it provides benefits to the region as a whole and demonstrates the state's commitment to reducing historically problematic traffic reputations. The segment of Route 9, the area's major access road, from the Garden State Parkway (exit 80) in Beachwood through Berkeley/Pine Beach connecting with Lacey Township, is operating at an extremely poor level service. Improvements to Route 9 are very difficult and expensive, due to the location of the existing buildings and other infrastructure. This traffic and transportation problem is not only an issue for Berkeley Township, but also Lacey, Beachwood, and Pine Beach residents as this segment of Route 9 also services them.

Berkeley Township has always been progressive in the planning for our community. We've established a Redevelopment Area and have Plan Endorsement from the State Office of Planning Advocacy (OPA). Berkeley continues to work closely with the OPA officials to renew our Plan Endorsement status. A major part of the Endorsed Plan is the Town Center Redevelopment area, which includes a new major connector road known as the Western Boulevard Extension. At least as early as 1997, Berkeley Township Masterplans and traffic circulation elements have identified the Western Blvd Extension as a key infrastructure improvement project. This includes moving traffic from the Pinewald area (adjacent to the Garden State Parkway) to the eastern portions of the Township. The extension of Western Blvd will help alleviate the traffic problems on Route 9 while also greatly improving the transportation infrastructure for Berkeley and the surrounding communities.

The Town Center Redevelopment area, situated along Route 9, has an assigned redeveloper who plans to improve the Town Center by providing goods, services, as well as much needed jobs to the local residents. The Township also plans to provide regional recreational opportunities, connections to the Ocean County Rail Trail, a solar energy project in the Community Solar program and a new indoor recreation facility. In addition, the project will accomplish the cleanup of a known contaminated site, known as the South Brunswick Asphalt site, which was owned by a defunct LLC with no assets. Over decades, the site fell into complete disrepair and was further damaged by Superstorm Sandy. The township was forced to condemn the property and demolish the hazardous on-site structures, and yet there remains significant environmental damage at the site. We continue to work closely with the Department of Solid and Hazardous Waste as well as the NJEDA HDSRF program and anticipate that the future tax payments (PILOT) from the redevelopment of the Town Center will assist with these cleaning costs, currently estimated to over \$20 million. However, without the Western Boulevard extension, the project will remain stalled.

This area of town is poised to become an integral part of our local and regional economy; however, the area cannot be fully developed without major improvements to the transportation network. As previously stated, improvements to Route 9 are very limited and the need for the Western Boulevard Extension has never been greater. The Western Boulevard extension is greatly needed to address the extremely poor traffic conditions on Route 9, accommodate the development of the Town Center Redevelopment Area, and assistance in the clean of the major hazardous waste site, all while providing good paying jobs, good services to our area resident and providing green energy infrastructure for the residents and the state.

I write today to seek your assistance. Berkeley Township is requesting financial assistance from the State for the design and construction of the Wester Boulevard Extension. We understand that there are several millions of dollars that will become available through the federal government infrastructure programs. Initial estimates for the cost to design and build the Western Boulevard Extension are \$19,729,132.80. The Township engineer has identified the immediate need for an updated study to a previous 2014 study on this project, expected to cost \$100,000.00 and a preliminary engineering and design phase, estimated to cost \$1,079,164. The proposed road is approximately a 2-mile stretch that will extend from Northern Boulevard to the Route at the intersection of Washington Street, at the Pine Beach/Berkeley border. Some preliminary studies have been performed; however, there are still more tasks to be completed to advance this worthwhile project. Our taxpayers cannot bear the burden of this regional transportation problem, as the redevelopment area will generate a Payment in Lieu of Taxes (PILOT), those monies are assigned to the future cleanup costs of the South Brunswick Asphalt Site.

We respectfully request FY24 Congressional Appropriations [in the amount of \$1,179,164 for the updated study and design phase, be considered for the funding of Western Boulevard Extension – Route 9 Connection. The Berkeley Township Police Department's Traffic Safety Bureau is in strong support of the Western Boulevard Extension project. This project will benefit the network of roadways throughout all of Berkeley Township and the surrounding jurisdictions. The project will relieve the severe problems that plague Route 9 which is operating at a poor level. The traffic problem on Route 9 effects not only Berkeley Township but also Beachwood, South Toms River, Lacey Township, Ocean Gate, and Pine Beach.

The two-lane highway of Route 9 has extreme congestion spanning from South Toms River to Lacey Township during all hours of the day. During rush hour time periods, the traffic is at a standstill in certain areas. This not only causes inconvenience but also poses great safety concerns. While traffic is at a standstill, views are obstructed by large volumes of traffic and tractor trailers causes pedestrian crossing concerns. The bumper to bumper traffic on Route 9 has also been the cause of 87 crashes during 2022 in Berkeley Township alone. Public transportation also poses concern for safety along the Route 9 corridor and its heavily congested traffic. The Township has several bus stops with very limited shoulders and no room for passing during loading and unloading. A relief in congestion would improve the level of safety for all of our motorist and pedestrian traffic.

With the always growing population and several new neighborhoods forming off of the Route 9 corridor, the growing traffic volumes not only effects the commuters safety but also the economic growth of our local businesses. The Traffic Safety Bureau receives traffic complaints on a daily basis in regards to the current infrastructure unable to meet the needs of the commercial transportation. Delivery vehicles experience great difficulty entering and exiting the commercial properties that they are required to deliver to. The circulation of traffic is vital to serve our community as well as the retail, industrial, and commercial land-uses.

With the Western Boulevard Extension acting as a bypass of Route 9, the community of Berkeley Township and the surrounding Townships will be greatly benefited. Approval of this project will address our safety concerns for motorist, allow for economic growth in our business district, and improve our Public Transportation infrastructure.
