Mr. SMITH of New Jersey (for himself and Mr. DOYLE) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To reauthorize the Combating Autism Act of 2006.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Combating Autism Re-
5 authorization Act of 2011”.

6 **SEC. 2. DEVELOPMENTAL DISABILITIES SURVEILLANCE**
7 **AND RESEARCH PROGRAM.**

8 Part R of title III of the Public Health Service Act
9 (42 U.S.C. 280i et seq.) is amended—

10 (1) in section 399AA(e), by striking “2011”
11 and inserting “2014”;

1 (2) in section 399BB(g), by striking “2011”
2 and inserting “2014”;

3 (3) in section 399CC(f), by striking “2011”
4 and inserting “2014”; and

5 (4) in section 399DD—

6 (A) in subsection (a), by striking “Not
7 later than 4 years after the date of enactment
8 of the Combating Autism Act of 2006” and in-
9 serting “Not later than 2 years after the date
10 of enactment of the Combating Autism Reau-
11 thorization Act of 2011”; and

12 (B) in subsection (b), in paragraphs (4)
13 and (5), by striking “the 4-year period begin-
14 ning on the date of enactment of this Act” and
15 inserting “the 6-year period beginning on the
16 date of enactment of the Combating Autism Act
17 of 2006”.

18 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

19 Section 399EE of the Public Health Service Act (42
20 U.S.C. 280i-4) is amended to read as follows:

21 **“SEC. 399EE. AUTHORIZATION OF APPROPRIATIONS.**

22 “(a) DEVELOPMENTAL DISABILITIES SURVEILLANCE
23 AND RESEARCH PROGRAM.—To carry out section 399AA,
24 there is authorized to be appropriated \$22,000,000 for
25 each of fiscal years 2012 through 2014.

1 “(b) AUTISM EDUCATION, EARLY DETECTION, AND
2 INTERVENTION.—To carry out section 399BB, there is
3 authorized to be appropriated \$48,000,000 for each of fis-
4 cal years 2011 through 2014.

5 “(c) INTERAGENCY AUTISM COORDINATING COM-
6 MITTEE; CERTAIN OTHER PROGRAMS.—To carry out sec-
7 tions 399CC, 404H, and 409C, there is authorized to be
8 appropriated \$161,000,000 for each of fiscal years 2011
9 through 2014.”.
