I am pleased to express my strong support for the funding request in the FY2024 Appropriations Process submitted by the Lakewood Study Square (LSS). It is my understanding that LSS is proposing to build a comprehensive senior center to offer services to seniors from Lakewood and the surrounding towns.

LSS' senior Connections program is long overdue, and will close a significant gap in service that currently exists in regards to Lakewood's growing senior population. As you well know, Lakewood experienced an astonishing 46% growth rate between the 2010 and 2020 census, and this growth has now brought Lakewood into the ranks of New Jersey's largest cities (4th largest.) One key contributing factor has been the growth of the senior community, both from long-time residents aging in place, as well as from an influx of seniors who have moved into Lakewood over the past few years. This changing senior population does not want to remain within the gates of Lakewood's senior villages as did Lakewood's seniors in years past. They are seeking community integration and community-based programming.

Most towns of our size would be expected to have numerous Senior Centers to offer programming to enable our seniors to remain healthy and social, and to preserve their community ties and their vitality far into advanced age. Yet Lakewood has no Senior Center and little formal programming for seniors. I therefore commend the Lakewood Study Square/Connections for their efforts to service the senior population, and for initiating this important project.



I urge you to fully support LSS's FY2024 Appropriations funding request. Please give this crucial project your full consideration. Dear Congressman Smith:

I am writing on behalf of the Lakewood Community Services (LCSC) to express our strong support for the request submitted to you by the Lakewood Study Square (LSS) for funding in the FY2024 Appropriations Process. This funding will be used to enable LSS' Connections program to acquire land to construct a senior center in which to centralize congregate meals, education, health and wellness, exercise and recreation and other programs for seniors.

We at LCSC are well acquainted with the growing needs of the senior population in Lakewood. Our organization has been providing kosher meals on wheels to local seniors with limited mobility for the past 20 years, and we are currently providing some 78,000 meals per year. As such, we have seen how, over the past few years, keeping pace with the phenomenal growth of the Township as a whole, Lakewood's Senior Population has evolved and changed.

Where previously seniors were concentrated in the senior villages and tended to be inward focused for socialization and other services, the new senior population in Lakewood seeks integration into the community. "Young seniors" who have lived all their lives and raised their families in Lakewood are now aging in place and retiring. This natural growth of the senior community from within is bolstered by a large influx of seniors moving in from outside of Lakewood – in order to be with their children who were drawn to Lakewood for educational and/or employment purposes. The diversification of the senior community; its spread into and throughout Lakewood – all lead to a need for additional services.

LSS has stepped up to the plate to establish the first, and much needed, Senior Center in Lakewood Township. We therefore urge you to support their funding request to enable LSS to build a full service hub to offer an array of needed services to help seniors preserve their health and vitality, draw them out to community settings to reduce isolation in a post-Covid world, upgrade their computer skills to be able to function in our digital society, and to offer recreational and socialization programming to create a sense of community and encourage positive social interactions.

We encourage you to do your utmost to support and secure funding in the FY2024 Appropriations Process for this important project. Thank you for your consideration.
