Dear Representative Smith,

I am writing on behalf of the Monmouth County Board of County Commissioners to outline our request for Federal Aid to design roadway safety and capacity improvements along the County Route 537 corridor in Monmouth and Ocean Counties.

The Route 537 corridor is the primary access roadway for several large traffic generators including Six Flags Great Adventure and the Freehold Raceway Mall. Additionally, the corridor serves as a major east/west regional connection between I-195, US Route 9, NJ Route 18 and NJ Route 33. Presently, the corridor carries 20,000 vehicles per day with a single lane in each direction and narrow shoulders. Unfortunately, the communities along Route 537 are facing significant challenges due to recurring traffic congestion and frequent vehicle crashes. This project is needed to mitigate traffic congestion and is supported by the "Western Monmouth Route 537 Corridor Study". Proposed roadway improvements include the addition of travel lanes, shoulders, and medians to improve both traffic flow and roadway safety.

In collaboration with our municipal partners and Ocean County, we are requesting \$2,500,000 to begin the necessary engineering and public outreach. With your support, we are confident in our ability to undertake this critical project to serve the transportation needs of the surrounding communities.

Dear Representative Smith:

I am writing regarding the proposed inclusion of funding for the design and engineering of Monmouth County's County Route (CR) 537 project, entitled "County Route 537 Corridor Improvements Section B," in the next Community Project Funding appropriation legislation.

As the Metropolitan Planning Organization for northern and central New Jersey, the North Jersey Transportation Planning Authority (NJTPA) oversees the region's Transportation Improvement Program (TIP). It is our understanding that the House Appropriations Committee requires assurance that any projects funded through the reauthorization legislation that are not currently in the TIP can and will be added to it. This letter serves to provide that assurance.

It is our understanding that the proposed project would address a high-accident corridor, currently featuring single lane one-way traffic that alternatively widens into two lanes going in a single direction, then merges back into single lanes. These mergers create a hazardous situation the Monmouth County Division of Engineering & Traffic Safety wishes to address with this project, which will create two lanes in both directions with shoulders from CR 571 (Trenton-Lakewood Road) near I-195 to CR 524 (Elton-Adelphia Road) in Jackson, Millstone and Freehold townships.

This project is located on a 5.7-mile stretch that is a major thoroughfare between I-195 and State Route 9. CR 537 crosses the state from Camden County through Burlington, Ocean and Monmouth counties. Workers from some of New Jersey's largest employers are located directly on or just off CR 537, including Six Flags Great Adventure, Joint Base McGuire-Dix Lakehurst, Naval Weapons Station Earle in your congressional district, and other large employers.

Please note that CR 537 Section B complements the county's CR 537 Section A project in Freehold. This \$20 million-plus federally funded project is included in the TIP and nearing construction.

The CR 537 Section B project is fully consistent with Plan 2050: Transportation. People. Opportunity., the current long-range plan for the NJTPA region. Plan 2050 encourages investing federal transportation funds to improve safety and to strengthen economic activity and tourism. Given this project's consistency with our long-range plan, the NJTPA would be able to add it to the TIP in a reasonable timeframe should it receive federal funding.
