I am writing to you on behalf of the Township of Wall to support the Township's Congressionally Directed Spending & Community Project Funding request for the Route 18 Bike Path Extension/Overpass Project.

The proposed project will provide a direct connection between the north and south sections of our municipality that have been divided by State Route 138 which is an extension of federal highway Route 195. The absence of a safe passage across these thoroughfares eliminates recreation opportunities for our residents and especially their children. As the Township Administrator of the Township of Wall, I have experienced the frustration by our municipal recreation staff and the local youth organizations as they attempt to design and deliver services while dealing with this man-made divide.

I am writing this letter on behalf of the **Wall Township Board of Education** to extend our **enthusiastic support** for the Township's application to the New Jersey Department of Transportation (NJDOT) in pursuit of funding through the **Safe Routes to School (SRTS) Grant Program**.

This application seeks to secure funding that will lead to critical safety enhancements for the students of Wall High School as well as the broader community. The proposed improvements are vital for ensuring the safety of our students who choose to bike and walk to and from school.


