On behalf of myself and the Belmar Borough Council, please accept this letter as our formal letter of support and request for funding necessary renovation projects of the Belmar Housing Authority (BHA) located at 710 8th Avenue.

The BHA runs a 50-unit apartment building that was erected in 1966 to provide subsidized affordable housing to seniors and individuals with disabilities. There are currently 50 residents.

We are grateful to you and your office for working with BHA on past renovation issues and for advocating for HUD emergency funding regarding the deteriorating façade of the building. The Belmar Housing Authority was recently awarded \$99,927 from HUD's Capital Funding and we appreciate your help in making this happen. The BHA can now pay for scaffolding to prevent loose bricks from falling onto residents and guests who are near the building.

Other parts of the building are in dire need of repair. Renovation is needed both on the façade of the building and on the interior. Water from heavy rains gets trapped behind the façade and leaks onto interior walls and into rental units. Another emergent matter is the need to modernize the elevator, which has been having issues since August 2022 when it shorted out after a power outage. This elevator is past its life expectancy and needs to be brought up to code. We were informed by the BHA that the total amount of repair work requested is \$676,000.

Accordingly, the Borough Council and I support the Belmar Housing Authority in its request to be considered for your Community Project Funding.

We appreciate any help you can provide to the BHA in order to keep our senior residents safe in their apartments and around this aging building. Our Belmar residents deserve to live in a safe environment. Thank you in advance for your consideration.
