



The project provides for two new roadways, one of which will run parallel to State Highway Rt. 9 which will ease traffic congestion by taking commuters off the most congested roadways.


I am writing this letter in support of the Township of Lakewood's appropriation request for road and infrastructure improvements. This proposed project is located in Lakewood's college district and includes an area of currently undeveloped land that runs parallel to Forest Avenue and extends from 9th Street to 14th Street in North Lakewood. The property will be redeveloped into several hundred housing units. Construction of roadways, utility service and other related amenities will be necessary. The project includes construction of two (2) roads, sidewalks, street lighting and associated improvements, sanitary sewer mains and infrastructure, drinking water mains and infrastructure, stormwater management, draining infrastructure and landscaping.

This project is part of a collaboration between the Township and its two institutions of Higher Education: Georgian Court University and Beth Medrash Govoha. The purpose of the project is to ensure that infrastructure and roads are in place to allow for the construction of several hundred of rental housing for families of students. This will alleviate the severe housing shortage present in the Township rental market, ease traffic congestion by taking commuters off the most congested roads and open a new

thoroughfare and exit roads from the College District. Lakewood Township is the fastest growing municipality in the state. As Lakewood has grown, it has also become an economic engine for Ocean County and the State of New Jersey.

I support the Township's efforts in pursuing funding and respectfully request your full consideration of the appropriation's request.


